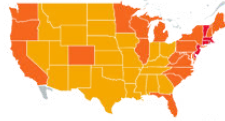


COVID-19 STATUS



- Covid cases are steadily rising across the country.
- Los Angeles (SeaCamp) and Riverside (AstroCamp) Counties have seen significant increase in cases over the past two weeks.
- Los Angeles County has extended the mask requirement on public transportation.
- With Memorial Day, graduations, and other end of school year activities, we expect cases to continue to increase making it a challenging start to our summer camp programs.

MASKING



- GDI intends to have campers wear masks as little as possible this summer. However, conditions may arise that require campers to be masked for extended periods of time.
- Masking will be optional outdoors.
- All campers will be **REQUIRED*** to wear masks indoors for the first 4-5 days of camp until the second round of Covid testing is completed. If conditions warrant, masking indoors will become optional.
- All campers should bring multiple high-quality and well-fitting masks.

***Unless campers present a mask exemption that is approved by our medical director.**



CAMPERS FLYING IN



- **FLIGHTS** - All campers flying to camp are **REQUIRED** to take a **rapid antigen test** prior to their flight(s). Rapid tests available for purchase below.

Any camper testing positive should postpone their flight and rebook for another camp session - if space is available.

TESTING



- **ARRIVAL DAY** - All campers are **REQUIRED** to test negative on arrival day. Sea Camp campers will test at the ferry terminal before heading to Catalina and AstroCamp campers will test upon arrival at our facility in Idyllwild.
- Any camper that tests positive for Covid-19 **WILL NOT** be permitted to attend that session. **THIS INCLUDES ANY CAMPERS THAT HAVE FLOWN IN.** Therefore, it is imperative for campers to limit contact, practice good masking, and test before their session and flights.
- **DURING CAMP** - GDI will test campers on day 4 or 5 of camp and if required due to exposure or if they are symptomatic.
- Any camper testing positive during camp will be **REQUIRED** to leave camp within 24hrs of their positive test.
- GDI is not responsible for providing housing outside of our facilities for any campers testing positive for Covid-19 if denied entrance to camp or if required to leave because of a positive test.
- Any international campers or those traveling long distance, should have an alternative location for their child if they are required to leave our facility.

Due to the ever-changing nature of the Covid-19 pandemic we reserve the right to modify protocols at any time.

PRE-ARRIVAL TEST RESULTS

Please complete the PRE-ARRIVAL SCREENING FORM under CAMPER ACCOUNT - 'Forms & Documents' WITHIN 24HRS BEFORE ARRIVAL.



If **POSITIVE**, complete the Pre-Arrival Screening Form under Forms & Documents, check the "Positive" box, input the test date, **AND CONTACT CAMP DIRECTOR IMMEDIATELY.**



If **NEGATIVE**, complete the Pre-Arrival Screening Form under Forms & Documents, check the "Negative" box, and input the test date.

ONLY WITH A TEAM EFFORT CAN WE BE SUCCESSFUL THIS SUMMER!

- **PLEASE** limit camper interaction with others the week prior to their camp session.
- **PLEASE** wear a high quality and well-fitting mask (N95/KN94/95) during travel to camp, especially on airplanes - even though it is not required.
- **PLEASE** test multiple times the week before coming to camp.
- If your child is sick in the week before they are due to arrive, **PLEASE** do not send them to camp.

We will work with you to find the best financial solution for your family, including a refund if necessary. If a COVID positive camper attends camp and the illness spreads, we may need to shut down camp for up to two weeks. Shutting down camp for even one week will severely impact our ability to serve children in future summers.
